Abstract text:

Livestock production is concentrated in certain geographical regions, some of which without enough area for agronomic valorisation of effluents, creating imbalance between "manure production and manure use". Therefore, in order to be competitive and comply with legal requirements, the sector must sear for alternative management strategies for its effluents which should promote a circular economy. The objective of this Operational Group, supported by PI 2020 (Portugal), is to valorise livestock effluents as a resource, focusing on the production and integrated management of the different flows generated at farm scale, optimizing their use as secondary raw materials, recovering energy and nutrients, improving farm nutrient balances and promoting sustainable management. The main activities to achieve these objectives are related with the four main routes: manure processing; feed and fertilizer replacement to develop a sustainable animal husbandry, bioenergy production in a livestock farm and biodegradation by Black Soldier Fly larvae. The main goal of the pro is the application of an established roadmap for effluents management and testing the weak and strong points to promote common advances in the nexus biowaste/energy/bio-fertilizer, closing the nutrients' cycle towards a sustainable bioenergy economy, creating a balance between manure production and manure use from 2018 onwards. The beneficiaries will be the animal producers and farmers and policy makers on manure use and production regarding legislation adpatation to new EU rules. This Operational Group (GOEfluentes) includes eleven partners from Research and Teaching, Agri Associations at Agri Enterprises.
